



HOUSE GUIDELINES FOR SPORTS TEAMS DURING COVID-19 PANDEMIC

Welcome to the Maritime Conference Center. To ensure the safety and comfort of all our guests, please adhere to the following guidelines:

- Please help us continue the downward trend of COVID-19 in Maryland. Keep your family together and practice common sense hygiene such as washing hands frequently.
- Face coverings must be worn at all times while in the public areas of the hotel. This is the law.
- Any person who is sick, or has recently developed symptoms of being sick, should remain quarantined in their guest room. Please notify the Front Desk immediately.
- Please maintain proper physical distancing from others who are not part of your immediate household at all times. There should be no gathering in the public spaces of the hotel, including the hotel lobby.
- Only two persons are permitted in an elevator car at a time, with the exception of households traveling together.
- Tampering with any health and safety measures (safety signage, guest room seals, sanitizing stations, etc.) puts other guests at risk and will result in immediate expulsion from the hotel.
- Adults must accompany minors in the hotel public areas, hallways and pool and fitness center at all times. Coaches, parents, chaperones and group contacts are responsible for the actions of their team members.
- Shirts and shoes must be worn at all times while in public areas.
- It is a misdemeanor in this County to tamper with or falsely set off a fire alarm. Any costs associated with a false alarm are the responsibility of the guest.
- Room keys will only be issued to adults over 18 years of age upon proper identification.
- A curfew of 10:00PM is in effect for all guests under 18 years of age.
- MCC is a 100% non-smoking hotel. Smoke stations are located outside. Smoking in a guest room will result in a \$250 cleaning charge.
- There is no running, shouting, roughhousing or horseplay accepted while on the hotel property. This includes hallways, lobby, stairwells, elevators, food service areas and guest rooms. Please keep guest rooms doors closed.

SERVICES

- **Breakfast Hours are 7AM to 9AM sharp.** Service is limited to hot and cold "grab and go" items. Limited capacity seating is available. Individual households may share a table, otherwise each person should be at a single table.
- The Fitness Center is open from 5AM to 10PM, with a maximum capacity of 6 persons at a time. Fitness center rules are posted outside the door. No unattended minors.
- The hotel Pool is open from 5PM to 10PM. Safety measures and physical distancing will be enforced by the lifeguard on duty.
- The Hotel Bar and Recreation Rooms are not permitted by law to be open at this time.
- An ice machine is located on the Lobby Level, turn left out of the elevator and proceed to the far end of the hall.



- If you require any items such as an iron or ironing board, please contact the Front Desk. We will make a no-contact delivery to your guest room.
- There will be no daily housekeeping service. If you require service, please contact the Front Desk and we will do our best to assist you.
- There is coffee and tea available in the lobby 24 hours a day. We also have a small convenience store beside the Front Desk that sells snacks, masks, hand sanitizer and other sundries which is open 24 hours a day.
