



## HOUSE GUIDELINES FOR SPORTS TEAMS DURING COVID-19 PANDEMIC

Welcome to the Maritime Conference Center. To ensure the safety and comfort of all our guests, please adhere to the following guidelines:

- **Please be kind to our staff! We promise to return the favor.**
- **If something is not right, please afford us the opportunity to make it right for you!** Negative comments on social media have lasting effects on businesses. We are inching our way out of the COVID pandemic like other businesses and your understanding is appreciated. We are a non-profit school for merchant mariners, who are essential workers to our recovering economy. Conference and group business helps to support this mission.
- Help us continue the downward trend of COVID-19 in Maryland. Keep your family together and practice common sense hygiene such as washing hands frequently. Wear masks in the common areas of the hotel such as the lobby, elevators and hallways.
- Any person who is sick, or has recently developed symptoms of being sick, should remain quarantined in their guest room. Please notify the Front Desk immediately.
- Please maintain proper physical distancing from others who are not part of your immediate household.
- Tampering with any health and safety measures (safety signage, guest room seals, sanitizing stations, house phones) puts other guests at serious risk. We will ask violators to leave the property.
- Adults must accompany minors in the hotel public areas, hallways and pool and fitness center at all times. Coaches, parents, chaperones and group contacts are responsible for the actions of their team members.
- Shirts and shoes must be worn at all times while in public areas.
- It is a misdemeanor in this County to tamper with or falsely set off a fire alarm. Any costs associated with a false alarm are the responsibility of the guest.
- Room keys will only be issued to adults over 18 years of age upon proper identification.
- A curfew of 10:00PM is in effect for all guests under 18 years of age.
- MCC is a 100% non-smoking hotel. Smoke stations are located outside. Smoking in a guest room will result in a \$250 cleaning charge. Also please be cautious not to generate too much steam from the showers – our system is very sensitive!
- There is no running, shouting, roughhousing or horseplay while on the hotel property. This includes hallways, lobby, stairwells, elevators, food service areas and guest rooms. Please keep guest rooms doors closed.
- Disorderly conduct by parents or children is not acceptable here. This includes public intoxication, vandalism or verbal/physical altercations with staff or other hotel guests. We will take whatever steps are necessary to protect the safety and welfare of our staff and other guests.
